General Chairman's Report – June 2023

#### **Brothers and Sisters:**

<u>Fatigue Risk Meetings</u> – Both CSX and NS have been developing fatigue risk management programs as a result of the intense scrutiny created by national negotiations and safety issues. One of the significant points developed is that fatigue is a part of the human condition. It is impossible to eliminate times of fatigue in the course of life. However, the program is trying to identify when fatigue becomes a safety risk for the member along with a mechanism to allow the member to reduce their exposure to potential injuries and accidents.

<u>NS Safety Consultant</u> – The carrier has employed Atkins Consulting to evaluate their safety culture and procedures. I met with the consultant and the carrier in a closed meeting to discuss IBEW concerns. The consultant will be traveling the system to meet at various locations with the local representatives as well.

<u>The Alabama State Docks</u> – Negotiations are ongoing. No agreement has been reached.

<u>System Council 6 E-board</u> - The contractual dues increase and process was discussed, along with deferment process. Deferment of previous years led to drastic increase in 2021 dues because of PSR impact on membership numbers; LU training was discussed with planned reach out to all locals for input; 2016 vehicle trade-in plan was discussed for GC vehicle use per bylaws — Council presently has two vehicles with secondary vehicle used by VGC. Multiple vehicles were a result of amalgamation of SC9. Issue to be addressed at 2025 Convention; 2025 Convention bylaw changes discussed due to need caused by amalgamation (E-board size, assets, how to fill E-board seats when LU does not send delegate); 2025 convention location suggestions (Gaylord Opryland; Disney)

NS Communication FCC License Issue – A recent bulletin assignment raised questions regarding the agreement language "FCC license or equivalent." Are college degrees considered an equivalent? No, the language pertains to the United States government's requirement.

NS Communication Payroll Error – In 2018, the communications agreements were consolidated. At the time, the Southern maintainers were making approximately \$70 more per month. In the negotiation, the existing N&W maintainers' pay was raised \$70 to balance the force. All new hires after the implementation date were to be hired at the previous lower rate as described in Rule 5. Payroll discovered that they had not been applying the correct rate to new hires. The pay rates will be adjusted with the next pay increase to reflect the correct amount. The carrier will not be retroactively recouping the overpayments.

<u>Active Claims:</u> Fifteen new NS cases were opened this month. Fifteen new CSXT cases were opened this month. In addition to normal calls and information requests, the Council is now currently handling 49 active cases. Any issue that involves disciplines/claims advanced to the Council, letter responses, medical delay documentation, RRB benefit issues, health insurance issues, etc., generate a case file with the Council.
