General Chairman's Report – February

Brothers and Sisters:

<u>CSX:</u> IBEW & IAM joint meeting to discuss our positions on flex rules. A mutual position was reached to present to the carrier. The carrier was agreeable to our language suggestions with the exception that they are still demanding lead mechanic changes to give them the right of appointment and no additional differential. Both organizations are opposed to this change. Meetings are continuing. Attended Redi Center student class

<u>Norfolk Southern:</u> Met with head of engineering and staff for communication issues. I was informed that the engineering department was the leanest engineering department in the freight industry. Job cuts are not part of any present plan and would be resisted if suggested. Additional training issues discussed as well as vacancy issues.

<u>Pan Am Negotiations:</u> The phase II implementation agreement was signed. This will bring the Pan Am electricians under the CSX Electrician's Agreement

<u>Norfolk Southern Lambert Point:</u> IBEW Forces are working under a temporary agreement which requires 4X10 shifts along with mandatory sign-ups for coverage of blank shifts during the agreement term. This type of scheduling is set to expire March 18, 2024 unless extended. At the termination of the temporary agreement, the work force will have been increased to the point of converting to regular three shift, eight hour days.

<u>Terminal Railway Alabama State Docks:</u> A tentative agreement was reached with the carrier. Members on the property were mailed information packets and ballots by System Council 6. March 10, 2024 is the deadline for ballot returns.

<u>Active Claims:</u> 13 new NS cases were opened this month. 20 new CSXT cases were opened this month. In addition to normal calls and information requests, the Council is now currently handling 53 active cases. Any issue that involves disciplines/claims advanced to the Council, letter responses, medical delay documentation, RRB benefit issues, health insurance issues, etc., generate a case file with the Council.

<u>LU 774 Video Meeting:</u> A productive meeting was held with Railroad Director Russo, International Representative Guiliano, System Council 6 officers, and members/officers of LU 774. Several communication issues were addressed. As a result, the Railroad Department will be sending out an updated assistance packet for filing of claims by locals.

NS AVP Engineering meeting: AVP Boyle stated that NS Engineering was the leanest staffed engineering department of all the Class 1 railroads. He has the numbers to support the position to any management change looking for job reductions. There is no current intent to reduce the force. Efforts are ongoing to increase the workforce. It was agreed to pursue discussion regarding updating the student agreement for communications.
